1.7 Justification of Proposal

Summary

With the moving of introductory sound courses from workshops into the core of Time Based Art in the BFA, the need arises for a sound class that is accessible to other BFA students, who can then, if they wish, go on to the elective stream of second and third level elective sound courses (SOMA3615 Sound Media 2 and SOMA3551 Sound Media 3.)

The SOMA2812 "Sound Studio : Introductory Workshop" (being deleted) was compulsory for TBA students but also open to other BFA students. Most of that course now moves into SOMA1551 Time Based Art 2B, so the need arises for a separate introductory audio elective course for BFA students that caters to general audio practise.

The existing elective (SART2551) has, as far as I can tell, never run, as SOMA2812 fulfilled the role of an elective option for non-Time Based Art BFA students. The SART number exists within the NSS system (I have checked with Rebecca Caddy r.caddy@unsw.edu.au) , but students have not been enrolled, except mistakenly in 2000 when the online enrolment system began (at the time I moved those students to SOMA2812).

To change the course name or number:

The course name changes to reflect changed content – it is not primarily a studio-based course, although studio practice is taught within the course.

The course prefix changes as the course is now located within the School Of Media Art, although the number stays the same, i.e. SART2551 becomes SOMA2551

to amend the Handbook description

The course will have less of a specific emphasis on time-based audiovisual practise (as it will no longer be Time Based Art students) , although this type of practise will be covered alongside other audio and audiovisual practices. The handbook description is also dated technically, and contains spelling mistakes and unnecessary repetitions.

to vary the pre-requisites or co-requisites

The course will require the BFA program to be a co-requisite.

to vary the unit of credit value

The course will move from 4UOC to 6UOC. A recent faculty-wide review of coursework programs has focussed on the need to achieve consistency of hours, expectations and units of credit. This course covers material that is equivalent to that covered in other 3 hours per week, 6 uoc courses.
