1.7 Justification of Proposal

Name change / Number Change

Time Based Art 2B offers an introduction to audio and audiovisual practice, which was previously taught within workshops. The coursework review process led to the determination that audio should be included within the core of the Time Based Art major. Thus this new course concentrates on concepts and technical skills related to audio and audiovisual practice relevant to students of Time Based Art. It also includes material from a former audio elective, from which it takes its number. That elective has not been previously run, as students were moved instead into workshops. SART changes to SOMA as Time Based Art is now in the School Of Media Art.

A recent faculty-wide review of coursework programs has focussed on the need to achieve consistency of hours, expectations and units of credit. This course covers material that is equivalent to that covered in other 3 hours per week, 6 uoc courses..

Changes have been made to reflect the move of the course content from workshop/elective to core major in Time Based Art .

Students will gain the conceptual and technical skills to develop soundscapes and audiovisual soundtrack work. Technically, the following elements are covered: Digital sound recording, editing and mixing; sampling ; synthesis; sound design. All students will gain proficiency on the basic operation of the sound studios. Various conceptual, aesthetic and philosophical approaches to sound and sound design will be introduced through critical discussion of examples and project work.
